New Year's Rifle Match  
December 29, 30 or 31, 2024

**Due to weather concerns we will announce the actual date of the competition on the [SEMNO Site](#) during the week prior to the above dates.**

**Weather:** *Due to the highly variable weather in Michigan during December, this match will be canceled if the forecast for all of the above dates calls for rain, fiery hail, or signs of the apocalypse.*

**Sponsored by:** The Midland County Sportsman's Club.

**Location:** The match will be shot at the Midland County Sportsman's Club, 8825 Sturgeon Road, Midland, Michigan.

**Rules:** Current NRA High Power Rifle Rules will govern. **FEES:** Price \$20.00, Juniors pay \$10.00. There is no penalty for a post entry.

**Time of Firing:** *Squadding will commence at 9:15 AM, at the clubhouse and end at 9:45AM. Firing will commence at 10:00 AM.*

**Awards will be based upon category providing there are more than five (5) competitors in a category.**

**Rifle Allowed for record firing:** There will be four divisions: Service Rifle – Rule 3.1, Any Rifle - Rule 3.2, F-Open – Rule 3.4 (a), and F-TR – Rule 3.4 (b).

**Special Conditions:** Local range rules require that each rifle and sight combination be verified at 100 yards prior to firing the match. Ladder targets will be provided, and verification shots will be taken immediately after the three minute preparation period. Verification shots will not be counted as sighters.

**Course of Fire:**

Match 1 Unlimited sighting shots and 20 shots for record prone in 22 minutes, slow-fire, 600 yards, MR target, Rule 3.7(c), any sights

Match 2 Unlimited sighting shots and 20 shots for record prone in 22 minutes, slow-fire, 600 yards, MR target, Rule 3.7(c), any sights

Match 3 Aggregate of matches: 1, and 2

**Target Service:** Electronic targets will be used. Competitors will be required to assist in set-up and take-down. An electronic device with a browser will be required for viewing shot location while firing and scoring.

**Directions to:**

**Midland County Sportsman's Club, 8825 Sturgeon Road, Midland, Michigan**

**From the East (from I-75).** Take US-10 to the Eastman Rd. exit. The exit faces Airport Rd. So just cross Eastman and go right onto Airport Rd. Sturgeon is 1 mile to the West. Turn North (right), Club is on left, about 1 1/2 miles.

**From the West (from US-27)** take US-10 to the Eastman Exit. That exits onto Wackerly Rd. Turn right (West) onto Wackerly off the exit. Sturgeon is about 1/2 mile West. Turn North onto Sturgeon and club is about 1 1/2 miles on the left.
